## AGREEMENT/JURISDICTION

THIS AGREEMENT IS MADE BETWEEN ERICA DIAMOND, HEREINAFTER KNOWN AS "STYLIST" AND , HEREINAFTER KNOWN AS "CLIENT", ON , (WEDDING DATE). . THE PURPOSE OF THIS AGREEMENT IS TO OUTLINE THE TERMS AND CONDITIONS FOR HAIR STYLING SERVICES PROVIDED BY THE STYLIST FOR THE CLIENT ON .

## LIABILITY

THE STYLIST AGREES TO PROVIDE HAIR STYLING SERVICES IN A PROFESSIONAL MANNER AND TO TAKE REASONABLE STEPS TO ENSURE THE SAFETY AND WELL-BEING OF THE CLIENT. THE STYLIST WILL MAKE EVERY EFFORT TO ACCOMMODATE ANY ALLERGIES OR SENSITIVITIES THAT THE CLIENT MAY HAVE, BUT THE CLIENT ACKNOWLEDGES THAT THERE MAY BE POTENTIAL ALLERGENS PRESENT DURING THE HAIR STYLING SERVICES. THE STYLIST IS NOT RESPONSIBLE FOR ANY LOSS, DAMAGE OR INJURY THAT MAY OCCUR AS A RESULT OF THE HAIR STYLING SERVICES PROVIDED, EXCEPT IN CASES OF GROSS NEGLIGENCE OR INTENTIONAL MISCONDUCT BY THE STYLIST. IF THE CLIENT HAS ANY ALLERGIES OR SENSITIVITIES, IT IS THE CLIENT'S RESPONSIBILITY TO INFORM THE STYLIST PRIOR TO THE START OF THE HAIR STYLING SERVICES.

## CLIENT RESPONSIBILITIES

THE CLIENT AGREES TO PROVIDE A CLEAR AND DETAILED DESCRIPTION OF THE DESIRED HAIR STYLE, INCLUDING ANY PHOTOGRAPHS OR SKETCHES, AT LEAST 14 DAYS PRIOR TO THE WEDDING DATE. THE CLIENT AGREES TO HAVE CLEAN AND DRY HAIR ON THE DAY OF THE WEDDING AND TO ARRIVE ON TIME FOR THE SCHEDULED HAIR STYLING APPOINTMENT. THE CLIENT ALSO AGREES TO PROVIDE A SAFE WORKING ENVIRONMENT FOR THE STYLIST, INCLUDING BUT NOT LIMITED TO, A CLEAN AND WELL-LIT AREA FOR THE HAIR STYLING SERVICES TO BE PERFORMED AND ACCESS TO ELECTRICAL OUTLETS FOR STYLING TOOLS.

## SERVICE START/END TIME

THE SERVICES PROVIDED BY THE STYLIST SHALL COMMENCE AT ON THE AND CONCLUDE AT . ANY CHANGES TO THE EVENT DATE, START TIME, OR END TIME MUST BE COMMUNICATED AS SOON AS POSSIBLE TO THE COORDINATOR AND MAY BE SUBJECT TO ADDITIONAL CHARGES.

---

## SECOND STYLIST

IF THERE ARE EIGHT OR MORE HEADS OF HAIR TO BE STYLED, A SECOND STYLIST IS REQUIRED AND EMPLOYED BY ERICA. IF THIS IS DEEMED NECESSARY BY ERICA, A \$75 SECOND STYLIST FEE PLUS MILEAGE WILL BE ADDED TO THE TOTAL DUE. SHOULD THE WEDDING TAKE PLACE OVER 90 MILES AWAY FROM LUBBOCK, TX, THE BRIDE/PERSON RESPONSIBLE FOR PAYMENT WILL ALSO BE REQUIRED TO PROVIDE THE TRAVEL FEE & ACCOMODATIONS AS OUTLINED BELOW IN THIS AGREEMENT.

# BRIDAL HAIRSTYLING SERVICE AGREEMENT

## RESCHEDULING

IF THE WEDDING IS RESCHEDULED, THE COUPLE MUST PROVIDE WRITTEN NOTICE TO THE STYLIST AS SOON AS POSSIBLE. THE RESCHEDULING REQUEST MAY BE APPROVED BASED ON THE STYLIST'S AVAILABILITY. IF SO, THIS AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT FOR THE RESCHEDULED DATE, WITH ALL TERMS AND CONDITIONS REMAINING THE SAME. IF THE STYLIST IS UNAVAILABLE, BOTH PARTIES MAY TERMINATE THIS AGREEMENT, AND THE DEPOSIT CAN BE PUSHED FORWARD FOR FUTURE SERVICES PROVIDED BY THE STYLIST.

## METHOD OF CANCELLATION

IN THE EVENT THAT THE CLIENT CANCELS THE HAIR STYLING SERVICES, THE CLIENT MUST PROVIDE WRITTEN NOTICE TO THE STYLIST AT LEAST 30 DAYS PRIOR TO THE WEDDING DATE. A NON-REFUNDABLE DEPOSIT WILL BE PAID THE DAY OF BOOKING.

---

## DISPUTE RESOLUTION

IF DIRECT COMMUNICATION DOES NOT LEAD TO A RESOLUTION, BOTH PARTIES AGREE TO ENGAGE IN MEDIATION BY A NEUTRAL THIRD PARTY. THE COST OF MEDIATION SHALL BE SHARED EQUALLY BETWEEN THE PARTIES. IN THE EVENT OF ANY LEGAL ACTION OR PROCEEDING RELATED TO THIS CONTRACT, THE PREVAILING PARTY SHALL BE ENTITLED TO RECOVER ALL ITS LEGAL FEES.

## CONFIDENTIALITY

THE STYLIST SHALL KEEP ALL OF THE COUPLE'S INFORMATION (E.G., CONTACT INFORMATION) STRICTLY CONFIDENTIAL AND AGREES NOT TO DISCLOSE IT TO ANY THIRD PARTIES WITHOUT THE COUPLE'S EXPLICIT WRITTEN CONSENT.

## INDEMNIFICATION

THE COUPLE AGREES TO INDEMNIFY AND HOLD HARMLESS THE STYLIST FROM AND AGAINST ANY AND ALL CLAIMS, INJURIES, LIABILITIES, DAMAGES, AND COSTS, INCLUDING REASONABLE ATTORNEY'S FEES, ARISING IN CONNECTION WITH THE SERVICES, EXCEPT IN CASES OF GROSS NEGLIGENCE OR WILLFUL MISCONDUCT.
