before the big day

TO SECURE YOUR DATE, A DEPOSIT OF \$125 IS REQUIRED, WHICH WILL BE SENT VIA INVOICE THAT I WILL EMAIL TO YOU. THIS INCLUDES YOUR TRIAL RUN, HOWEVER, YOU MAY ALSO PAY SEPARATELY FOR A TRIAL PRIOR TO SIGNING A CONTRACT AT A RATE OF \$65. YOU MUST ALSO COMPLETE THE SERVICE CONTRACT LOCATED ON OUR SITE TO SECURE YOUR DATE.

TRIALS ARE ONLY NEEDED FOR THE BRIDE, AND MUST TAKE PLACE IDEALLY 2 TO 3 MONTHS BEFORE THE WEDDING, NO LATER THAN A MONTH BEFORE THE WEDDING. PRIOR TO YOUR TRIAL RUN, PLEASE SEND PICTURES OR A PINTEREST BOARD OF INPO PHOTOS MATCHING YOUR HAIR TYPE, LENGTH, COLOR, AND THE STYLE YOU WOULD LIKE FOR YOUR BIG DAY. PLEASE COME TO YOUR TRIAL RUN WITH FRESHLY WASHED AND BLOWDRIED HAIR, FREE FROM PRODUCT.

ON THE DAY OF THE WEDDING, PLEASE HAVE ALL BRIDAL PARTY MEMBERS TO BE STYLED ARRIVE WITH FRESHLY WASHED AND BLOWDRIED HAIR, FREE FROM PRODUCT UNLESS THEIR HAIR IS NATURALLY CURLY AND REQUIRES A CERTAIN PRODUCT. BRIDES NEED TO ALLOW 1.5 HOURS FOR COMPLETE STYLING, OTHER BRIDAL PARTY MEMBERS TO BE STYLED NEED TO ALLOW 1 HOUR PER MEMBER.

CANCELLATION POLICY

IF WE HAVE COMPLETED YOUR TRIAL AND/OR BRIDAL STYLE AND THE CANCELLATION IS ON MY END, YOU WILL BE REFUNDED A PORTION OF YOUR DEPOSIT SO THAT THE STYLES COMPLETED ARE COMPENSATED FOR.
